For clarification purposes, referencing the information on page 18, please read below.

Bid Bond Information: Citing Code of Virginia §2.2-4336 "bid bond from a surety company selected by the bidder that is authorized to do business in Virginia, as guarantee that if the contract is awarded to the bidder, he will enter into the contract for the work mentioned in the bid". Bidders can furnish a certified check, cashier's check, or cash escrow in the face amount required for the bond, in accordance with (Citing Code of Virginia) §2.2-4338. The bid bond must be for a period of not less than 30 days after the bid opening date. Bond or check shall be made payable to the School Board of Essex County Public Schools.
