3. Reference Page 2 section 3, Opening Date: Change to read “Opening Date of December 11, 2020, at 10:10 a.m.
4. Reference Page 8 section 14.1, Standard Terms and Conditions: Change to read “exceeds \$100,000”.
5. Reference Page 18, section 3, bullet a., Bid Due Date: Change to read “Bids will be accepted until December 11, 2020 at 10:00 AM. Bids received after this date and time will not be considered.”.
6. Reference Page 18, section 3, Digital Copy: Digital copy is not required.
7. Reference Page 19 section #4, Bid Due Date: Change to read “Bids received after December 11, 2020 at 10:00 AM will not be considered”.

Amended drawings, from the architect, are forthcoming. An addendum will be issued and notifications will be updated on eVA, The Rappahannock Times newspaper, and Essex County Public Schools’ website.

For clarification purposes, referencing the information on page 18, please read below.

Bid Bond Information: Citing Code of Virginia §2.2-4336 “bid bond from a surety company selected by the bidder that is authorized to do business in Virginia, as guarantee that if the contract is awarded to the bidder, he will enter into the contract for the work mentioned in the bid”. Bidders can furnish a certified check, cashier’s check, or cash escrow in the face amount required for the bond, in accordance with (Citing Code of Virginia) §2.2-4338. The bid bond must be for a period of not less than 30 days after the bid opening date. Bond or check shall be made payable to the School Board of Essex County Public Schools.

Note: A signed acknowledgment of this addendum must be received at the location indicated on the IFB either prior to the bid due date and hour or attached to your bid. Signature on this addendum does not substitute for your signature on the original bid document. The original bid document must be signed.
